

Faculty Information & Activity Tracking

IOTA360™ keeps all of the critical information about your faculty in one place. Credentials, certifications, publications, honors, CVs, peer reviews, biographical information – it's all stored and correlated by IOTA360™. This enables your institution to utilize all of this information for problem-free scheduling, custom reporting and data-driven decision-making. The system allows faculty or administrators to upload corroborating data (degrees, transcripts, etc.) which can then be viewed and verified by administrators. IOTA360™ can also provide you with the reports to help you at accreditation time. Numerous user "roles" are established to define how much administrative data access is available to each individual administrator.



Course Schedule Management

IOTA360™ makes scheduling of courses and other faculty activities a breeze. The system can easily restrict which faculty can be assigned to a course based upon their specific vetting, credentials, location or scheduling limitations (such as Affordable Care Act conflicts). This information, in concert with the Contracts Management data, then feeds directly into the Invoicing module for quick and accurate faculty payments. Because of IOTA360's flexible role-based architecture, authorized users can schedule any course at any school, location, building and classroom in their purview, and even specify the weekly class times. Instructors can be assigned and re-assigned at any point.

To help with ACA compliance, the number of credit hours being scheduled for any adjunct instructor is displayed across all schools and campuses, and a warning can be issued when that number of hours exceeds a customizable threshold. This is especially useful in community college systems, where often 80% to 90% of instructors are adjunct, independent contractors working for multi-campus schools.

Contracts Management

IOTA360™ hosts and manages instructor teaching contracts and billing rates for faculty. These rates can be defined based on the course characteristics (Delivery Method, Grad/Undergrad, number of students, etc.) or customized per faculty member. New rates can be entered by administrative personnel as necessary. These contracts can then be viewed by the faculty members and electronically signed.

This module provides all of your course evaluations within the context of the Faculty Information and Activity Database. IOTA360™ allows for student evaluation, peer rating (by other faculty), self-evaluation and administrator rating for a complete "360 degree" view of faculty or department performance and effectiveness. This is a multi-tier module that is designed to capture data through surveys and data importing. IOTA will establish a customized Security Matrix of access and permissions to ensure the confidentiality of all data. Numerous standard reports allow both faculty and administrators to analyze their results in an efficient, timely manner.

Assessments:

IOTA360 Assessments™ is designed to help you increase your effectiveness in two ways. The Student Learning Outcomes module allows you to assign reviewers to rate your students' educational progress using your existing outcome criteria and artifacts, uploaded or designated by the faculty ("Rubric based") or by the results of an outcome test ("Performance Based"). The Faculty/Staff Review module is designed to allow your faculty or staff to be evaluated by any number of self-picked or assigned reviewers with whom they work. These reviewers can be outside of the institution. In both cases comprehensive reporting allows you timely and efficient access to the results of the reviews.

Custom Report Generator

IOTA360™ comes complete with a robust, full-featured custom report generator, allowing administrators to produce timely, complex reports in a matter of minutes. These reports can be saved to be shared with others, and they can also be exported to PDF or CSV format for easy integration into 3rd party applications.

Faculty Resource Library

Schools can place resources in this online environment for the entire faculty or segregated by department and/ or school. For instance, example lesson plans, standardized handouts and examinations, and HR-related information. The library can contain files of any type, videos, or even external links to other sites. The library also has a section dedicated to individual faculty members, allowing them to post items or files of particular interest.
